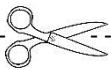

Please note . . .

1. **There are two required forms.** Enter all info on the state-required authorization card **above**. Then fill out yellow portions and sign and date the membership form **attached** (this membership form will only be submitted for dues deduction if a union is formed. Dues are approx. \$77 a month, mid-August to mid-May).
2. **When a majority of the faculty sign this card, no election on the question of representation is required – the card effectively serves as your vote.** Signing the card indicates that you want IEA/NEA to be your bargaining agent.
3. **The cards will be filed with the Illinois Educational Labor Relations Board (IELRB)**, which is an impartial state agency in Springfield. *The cards are confidential and your employer never knows who signed.* Typically, your unit will be certified within 30 to 45 days, after which bargaining can begin within 60 days.
4. **Meanwhile, members of the ISU Faculty Association-IEA/NEA** will create bylaws, elect officers, prepare for bargaining and sign up more members (to increase bargaining strength).
5. **Please fill out these forms in the presence of a campaign volunteer** – they will not be handing out forms for you to take, but may provide you with other information. They can re-visit you with answers to questions you may have. Meanwhile, check out [www.isufa.org](http://www.isufa.org) for more information.
6. **Detach the lower half of this sheet for your records** – retaining it means you understand the purpose of the form and the process toward representation.
